Retreat Goal

To create priorities for a team to develop a multi-year policy strategic plan.

This plan will then drive what specific policy activities we undertake 2023 - 2028.

Global, National and State Policy Overview

Global plastics treaty

175 member countries adopted UN resolution

Full lifecycle of plastic, including its production, design and disposal

Long-term elimination of plastic pollution, in marine and other environments

Sustainable production and consumption of plastics

Federal funding is coming this fall!

Infrastructure

- \$55M/yr, 2022-2026
- Funding for states and tribes
- Improving recycling infrastructure for post-consumer materials

Education

- \$75M/year 2022-2026
- Education grants to improve community recycling for government, tribes, public-private partnerships, nonprofits
- EPA to develop model education toolkit

Batteries

- \$110M in grants from DOE
- Collection and labeling best practices
- Covers wide range of batteries

Most promising federal bills in 2022



Recycling and Composting Accountability Act

- Passed Senate in July
- National composting strategy
- Improve recycling and composting data



Recycling Infrastructure and Accessibility Act

- Passed Senate in July
- Grant program for rural and disadvantaged communities
- \$500k \$15M for projects

Nearly 20 active bills in Congress

Break Free From Plastic Pollution Act

• National EPR and bottle bill; ban on plastic bags and polystyrene food containers; PCR requirements for plastics; promote reuse/refill; moratorium on new plastics production facilities

Secure E-Waste Export and Recycling Act

Ban on e-waste exports, supporting Basel Treaty

REDUCE Act

• 10 cents/lb fee on virgin plastic for single-use plastics; funding for recycling, reduction, clean-up

Food waste

- Zero Waste Food Act: \$650M/yr to reduce and prevent food waste
- School Food Recovery Act: measure, reduce food waste in schools
- Food Donation Improvement Act

Meet with Solid and Hazardous Waste Commission to increase tipping fees		Goes beyond CDPHE authority, FRWD increased tipping fees via legislation

Evaluate waste composition studies, allocate funds to conduct studies	Provide assistance for data collection	RREO regional studies included waste composition, have not tracked Percent of Recoverable Remaining

Where have we been? What have we accomplished? Assist in Regional Planning

Regional Planning & Trainings	Provide technical assistance and funding on diversion strategies, best practices and to create waste diversion plans	FRWD and RREO regional planning; CDPHE completed site visits, training webinars, regional outreach meetings
Partner with regional planning agencies/encourage development of Eco-Parks	Support recycling cooperatives, solid waste authorities, and rural groups	CDPHE has met with DRCOG and few other regional planning groups; supported Larimer County

Where have we been? What have we accomplished? Assist Rural Communities

Inspections and Incentives	Designate funding to assist rural landfills with compliance	Installed monitoring wells, conducted groundwater sampling, provided guidance on landfill design and operations
	Designate funding sources to assist rural communities with implementing their own waste diversion plans	RREO, Producer Responsibility Act

Where have we been? What have we accomplished? Require the State to Lead on Zero Waste and Climate

Zero Waste Strategies in CDPHE Operations	Require state agencies to recycle and compost, strengthen green purchasing policies, require use of compost in construction	75% diversion goal set at CDPHE, ongoing monitoring
	Support recycling and compost as a strategy to meet the state's climate action plan	Incorporated into GHG Roadmap

Work with CDOT to relax fees/regulations to facilitate backhaul of recyclable material to market		Unclear if CDPHE has ability to influence CDOT; Circular Economy Center may be able to address this
	Provide incentives and technical assistance to attract new and support existing end use businesses	RREO, FRWD, Circular Economy Development Center

	Develop partnerships with universities, businesses and nonprofits to conduct research on end markets	Circular Economy Development Center
	Ban materials from landfills to drive recycling end markets with support or exemptions for rural areas	Electronics landfill ban
