

Using Waste Composition Studies as a Tool for Expanding Your Recycling Program

Twilight

Waste generation is one of the significant environmental impacts of our daily operations. In assessing the opportunities of any recycling program (business, city, county, etc.), it is important to quantify the various components of our waste/recycling stream, evaluate the effectiveness of the current recycling program, and identify areas for improving both the current and future recycling efforts. Using the data collected during a waste study, you can identify ways to reduce waste, enhance recycling efforts, and determine the potential for cost savings. Studies can be done on any type of waste, and there are a number of different ways to conduct them, such as visual waste audits, waste characterization, and desktop audits. Come and learn from subject-matter experts on how to develop and conduct waste audits and waste composition studies to improve the effectiveness of your program. This session will include hands-on approaches and how to's on conducting a composition study to improve the effectiveness of your program.

"Sustaining Yellowstone National Park: A 138-Year Journey"

Yellowstone National Park created the "Greening of Yellowstone" concept in 1995. Since then, the park has made remarkable progress in promoting sustainable practices and advancing sound environmental stewardship initiatives. This has been accomplished through the fostering of partnerships, coupled with a very aggressive education and outreach component to over three million annual visitors. Evanoff will focus on the challenges of collaborating with both public and private entities to ensure success in instituting unique environmental programs, including a very successful and innovative recycling program.

Bio: Evanoff is the Environmental Protection Specialist for Yellowstone National Park. His career with the National Parks Service spans three decades; he has been stationed at Yellowstone since 1988.

Product Stewardship

Product stewardship can help save taxpayers money and protect the environment by incorporating lifecycle costs into the product purchase price. During the first half of this session PSI Founder and Executive Director Scott Cassel, along with PSI Senior Associate Sierra Fletcher, will discuss PSI's Principles of Product Stewardship that helped guide the growing movement, with producers playing a primary role within the context of shared responsibility for product management. Scott and Sierra will discuss how the movement has taken hold in the US and how stakeholders can work together in Colorado to reduce product impacts. They will provide an overview of product stewardship activities in the United States, including electronics, thermostats, batteries, paint, and pharmaceuticals, and offer suggestions for steps Colorado can take in the coming year.

In the second half of the session Anne Peters of Gracestone, Inc. will discuss Colorado's experience with e-waste legislation (Colorado's first attempt at Extended Producer Responsibility) followed by a facilitated discussion about the emerging Colorado Product Stewardship Council. Come find out how you can be involved and help plan how this new group will: Educate state and local officials, private organizations and waste haulers on the concept of product stewardship; improve communication about this issue within the recycling, solid waste, and household hazardous waste management communities, other interested parties, and relevant government agencies and departments; raise awareness of existing product stewardship programs with household hazardous waste management agencies and other applicable programs and parties; help CAFR formulate policy positions related to product stewardship legislation.

Community Recycling: Single Stream Collection Systems and Education

This panel will focus on the collection systems, education and outreach necessary to implement a successful single stream recycling program.
