

# WELCOME TO THE SUMMIT

On behalf of the Colorado Association for Recycling Board of Directors, Summit Planning Committee and staff, we welcome you to Vail and thank you for joining us for the Rocky Mountain region's premier recycling conference!

As always, we thank our sponsors (page 7), our exhibitors (page 5), and our many volunteers, whose financial support and generous efforts make the Summit possible. This year we have several speakers from out-ofstate and we extend to them, and to all of our local speakers, a special thank-you for taking the time to contribute to our conference. And thanks to all of you, the Summit attendees, for joining us and sharing your ideas and expertise.

### **The Harsh Realities**

We'd like to introduce this Summit by telling you that recycling rates are soaring in Colorado. However, despite our efforts, the unvarnished truth is that with low landfill tip fees, a geographically dispersed population and one of the lowest MSW recycling rates in the country, overall recycling rates in Colorado have remained low for the past several years and may even be declining. We're making a special effort this year to focus the Summit on these troubling facts and asking YOU, our local recycling industry leaders, to put your imagination to work to find innovative ways to reinvigorate recycling in our state.

# What Can We Do Differently?

To help us in this process, we designed The Triumvirate Recycling Panels. We invited industry representatives from different parts of the country, where the economic and demographic circumstances are not that much different from those in Colorado. These leaders – who will form our first plenary panel (Part 1) – have already submitted some of their success stories to a second panel of local recycling leaders who have been examining their potential application in Colorado. This second panel will discuss these ideas with you in Part 2 before submitting a series of recommendations to a third plenary panel comprised of prominent Colorado legislators and policy makers (Part 3).

In addition to The Triumvirate Recycling Panels, we'll hear from two organizations that are successfully engaging private capital to create new recycling models in other states (why not in Colorado, we ask?) and from many of our local recycling leaders who will present fresh thinking and innovative ideas for creating new models with the potential to break Colorado out of the recycling doldrums.

## It's Up To All Of Us

We urge you to participate in these sessions vigorously, leverage the ideas you're hearing, and think outside the box. What COULD we do in Colorado that we're NOT doing and what would it take to get it done? CAFR intends that we all emerge from this Summit with a clear plan to partner with our local policy makers, private investors, and imaginative local government organizations to create half a dozen revolutionary models that will put Colorado back on the recycling map.



#### Are Public/Private Partnerships Boosting Recycling?



Funding recycling programs has always been the province of local government agencies or small nonprofits. That is until the past few years when several major corporations have funded models with the objective of creating public/private partnerships to promote recycling. Representatives from two of these, The Closed Loop Fund and The Recycling Partnership, describe the objectives of their models, what criteria they use to identify promising opportunities, how the funding processes work, and what successes they are seeing in their projects to date.

Rasham Grewal explains that early, effective, and – importantly - ongoing education programs are key to securing widespread public participation in recycling programs.
